

Happy Valley's Got Talent Contest purpose is providing a vehicle for encouragement, development and discovery of entertainers

ELIGIBILITY/ENTRY Canyon Casting Talent Contest is open to those people 18 years of age or over. Each Contestant must provide a head shot and resume. Time limit for each act must not exceed five (5) minutes. Any act running over 5 minutes will be disqualified. Acts will be timed. No acts using batons, machetes, or knives, etc. will be accepted. No fire will be allowed on stage during the competition. This also applies to our Prelims, Semi-Finals & Finals. Any violation of this rule will result in a disqualification. Contestants using recorded music for their performance must deliver a cd in to Canyon Casting at the time of audition. It must contain only the selection to be performed on it. We will be videotaping each act. A piano and sound system is provided by Canyon Casting(Canyon). An Accompanist is available for an additional fee of \$5 at the time of the competition.

The entry fee for the talent contest is \$10 and includes a ticket to the Talent Show regardless if the contestant is chosen to perform as a finalist July 3rd or July 11th 2009.

The decision of the judges will be final

PRIZE

Grand Prize Winner - One grand prize per event ("Grand Prize") will include a 6 month contract with The Price Group Talent Agency.

To be eligible to enter, a Contestant and/or Entrant ("Contestant") must be a United States resident.

Canyon Casting will have the sole and absolute discretion to determine the validity of all Entries and/or its agents, reserves the right to contact any Contestant for any reason including to entry confirmation or to request additional Photographs.

Submission of Photographs and Entry in the Contest constitutes the grant and consent to the perpetual, royalty free, unrestricted right to use the Photographs and the Contestant's information provided on the registration application, for all purposes and in all media now known or hereafter devised, including the right of reproduction thereof, and the right to photograph and/or video Contestant, and to use such images and/or video for all purposes and in all media now known or hereafter devised and other media channels and applications, and for advertising, promotions, other

contests sponsored by Canyon Casting or any related or affiliated company and other commercial purposes..

Entries are not being submitted in confidence or in trust and are not intended to remain confidential. Entries will not be returned. Contestant agrees that any Entry or other content whatsoever posted or provided by Contestant becomes the property of Canyon and may be used for all purposes, reproduced, copied, sub licensed, adapted, transmitted, translated, distributed, publicly performed, displayed or deleted, in perpetuity and in all media now known or hereafter devised, including the right of reproduction thereof as Canyon may determine in its sole and absolute discretion.

Each Contestant (including but not limited to the winner), as a condition of entering the Contest generally, shall acknowledge and agree that Canyon and/or its related or affiliated entities shall have the right to, without further authorization, publicize her Entry, name, character likeness, photograph, voice, and/or the fact that she is a Contestant or the winner, for, without limitation, advertising and/or promotional purposes, without the payment of financial remuneration to the Contestant.

SELECTION OF GRAND PRIZES WINNER AND FINALISTS

Canyon and/or its designated agents will select five 10 to 15 for Final Round Competition from the pool of auditioned contestant applicants. Grand Prize will winner will be chosen by a pre-determined panel of three (3) to five (5) pre-selected judges ("Judges").

Decision of Judges

If any Contestant, including the winner is determined to be ineligible, withdraws from the Contest, breaches any representation or warranty contained in these Official Contestant Rules & Regulations ("Official Rules") or fails to satisfy any of her promotional or marketing obligations, including any obligations under the Promotional Contract Canyon reserves the right to replace them.

COLLECTION OF PRIZE

The winner will be required to sign the Talent Agency Contract in such form as is reasonably requested by Agency without additional consideration, in the 6 month period following the date of the finals.

REGULATIONS

Canyon reserves the right to cancel or terminate the Contest or make rules or Contest changes, including prospectively and/or retroactively, without notice and at any time, at its sole, absolute and exclusive discretion, and reserves the right to change any aforementioned Contest date(s) without notice.

Any decision by Canyon and/or its designated representatives, in their sole discretion, in the interpretation and/or application of these rules shall be final. By participating, Contestants and/or the winner agree to be bound by

the decisions of Canyon its designated representatives, any judges, and the official rules.

Canyon together with its related or affiliated companies and other entities, and its and their representatives, owners, agents and employees, are not responsible for any liabilities arising directly or indirectly from the award of or participation in the Contest or Prize.

All federal, state/provincial and local laws and regulations of the United States and/or other countries apply. Void where prohibited or restricted.

Contestants agree to be bound by these Official Rules.

There is no purchase necessary to enter or win the Contest. The Contest is void where prohibited, regulated or taxed. This Contest shall be governed and construed by PA. Law. All federal, state/provincial and local taxes are the exclusive responsibility of the Contestants. Participation in the Contest and Prize awarded are non-transferable.
